Hurley, in turn, gained the support of oilman Frank Phillips, founder of Phillips Petroleum Company in Bartlesville, Oklahoma. Although the Phillips Collection contained historical manuscripts, the University Libraries also gathered materials for its own Manuscripts Division, which operated independently of the Phillips Collection. This separate division began in 1948 with a grant from the Humanities Division of the Rockefeller Foundation.
