Listing your references on the page isn't your last step in this process. If you haven't already, ask permission from each of your references. It's important only to submit the names of people who have agreed to serve as a reference. When you're emailing a reference list to an employer, name the file so that it's easy to identify and easy for the hiring manager to keep track of. You may want to send it as a PDF file, so it retains the original formatting. Here's how a reference list is the detailed list of references that are cited in your work. A bibliography is a detailed list of references cited in your work, plus the background readings or other material that you may have read, but not actually cited. Recruiters and hiring managers may contact people on your reference list during the hiring process to learn more about your professional history, job performance and other details about the kind of employee you are.
